I have read, understood, and agree to the terms and conditions outlined above.

TO: MUSQUODOBOIT VALLEY OUTFITTERS, all related companies and their respective owners, directors, officers, employees, agents, representatives, instructors, guides, contractors, subcontractors, suppliers, sponsors, successors and assigns, and to the manufacturers and distributors of the rental equipment, and their directors, officers, agents and representatives, and His Majesty the King in the Right of the Province of Nova Scotia (all of whom hereinafter collectively referred as "the Releasees").

DEFINITION:

In this Release Agreement Canoeing, Kayaking, Hiking, Backpacking, Camping, Portaging, and Transportation (hereinafter "the Activities") shall apply to all activities, events or services provided, arranged, organized, conducted, sponsored or authorized by the Releasees including but not limited to: whitewater, still water, moving water, and ocean canoeing and kayaking; rental of canoes and kayaks (hereinafter "the boats"), and other equipment; use of safety equipment including but not limited to personal flotation devices and orientational sessions; loading and unloading of vehicles and boats; and all activities, travel, transportation and accommodation while utilizing the Releasees facilities and equipment.

I acknowledge that I have been advised to wear a personal flotation device (lifejacket) at all times while using a boat. Instruction as to the proper use of the personal flotation device is available from the staff. I am aware that wearing a personal flotation device does not eliminate the risk of being injured and only minimizes the risk of injury and/or death. I am aware that participation in the activities may involve sudden, violent and unexpected movements, which may result in injury or aggravation of previous injuries.

I acknowledge that I have been advised to seek medical advice before engaging in the activities if I know or suspect that my physical condition may be incompatible with the Activities. I certify that I am physically capable and fit to participate in the Activities and have no medical, physical, or emotional conditions that could cause harm or loss to me and/or others during my participation.

ASSUMPTION OF RISKS

I am aware that the Activities involve many risks, dangers and hazards including, but not limited to: accidents which occur during transportation or travel to and from pick-up and drop-off points; slips, trips, and falls; overturning or upsetting of boats; loss of balance; impact, collision with or entrapment by trees, logs, deadfall, boats or equipment; drowning; hypothermia; changing and inclement weather conditions including storms, high wind, high waves, and lightning; equipment failure; encounters with domestic or wild animals; the failure to boat or hike safely within one's own ability or within designated areas; human error, failure to forecast or recognize a hazardous situation, failure of the Releasees to predict whether the terrain used is safe for the activities or whether an accident may occur; uncontrolled, unmarked, or inspected terrain; negligent first aid; negligent rescue efforts; and negligence on the part of other participants or Releasees, including failure to follow applicable rules and procedures, and risks resulting from the NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF ANY STATUTORY DUTY OF CARE BY THE RELEASEES, and the failure by the Releasees to safeguard or protect me from the Activities' risks, dangers and hazards.

I also understand that the other risks of participating in the Activities can include exposure to the elements, exposure to natural and/or people-made objects, exposure to pollution, exposure INFECTIOUS DISEASE CONTRACTED THROUGH VIRUSES, BACTERIA, PARASITES, AND FUNGI WHICH MAY BE TRANSMITTED DIRECTLY OR INDIRECTLY, INCLUDING BUT NOT LIMITED TO COVID-19, that results in physical distress, illness or death; as well as the risk of collision or impact with other participants, objects, or vehicles; variable and difficult terrain conditions; fatigue; intoxication; consumption of drugs; sun or heat exposure; encounters with wildlife, poison ivy, or insects/rodents; loss of balance or control; and failure to act safely or within one's own ability or to stay in designated areas.

Communication in both land and water terrain used is difficult and in the event of an accident, rescue and medical treatment may not be available. Weather conditions may be extreme and can change rapidly and without warning, making travel by any means hazardous.

I am also aware that there is a risk of NEGLIGENCE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THERELEASEES TO TAKEREASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF THE ACTIVITIES AND THE USE OF THE RELEASEES' PREMISES. I FREELY ACCEPT AND FULLY ASSUME ALL RISKS, DANGERS AND HAZARDS ASSOCIATED WITH THE ACTIVITIES AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE OR LOSS RESULTING THEREFROM.

I UNDERSTAND NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES TO TAKE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF THE ACTIVITIES REFERRED TO ABOVE; I HEREBY AGREE THAT THE RELEASEES SHALL NOT BE LIABLE FOR ANY SUCH PERSONAL INJURY, DEATH, OR PROPERTY LOSS AND RELEASE THE RELEASEES AND WAIVE AND ALL CLAIMS WITH RESPECT THERETO.
