



MUSQUODOBOIT VALLEY OUTFITTERS 2024 RENTAL AGREEMENT

General

1. The person making the reservation (i.e., the reservation holder) is required to complete one rental agreement on behalf of all guests included in their reservation.
2. All guests are required to complete a Release of Liability Waiver. Guests under the age of 19 must have a parent or legal guardian complete the Liability Waiver on their behalf. Liability Waivers can be found in the dropdown menu under “Rentals” in the site navigation menu.
3. Minors (persons under the age of 19) must be accompanied by a parent or legal guardian.
4. Musquodoboit Valley Outfitters encourages all guests to review and abide by the 7 Principles of Leave No Trace (<https://lnt.org/why/7-principles/>) while enjoying Nova Scotia’s great outdoors.

Safety

5. Maximum 1 person per seat in kayaks and canoes; one additional adult or additional small children may be permitted in select canoes, subject to the discretion of Musquodoboit Valley Outfitters.
6. Musquodoboit Valley Outfitters encourages all guests to review the Safety Resources included on our website (<https://www.mvoutfitters.ca/safety-resources>) and the Travel and Survival Tips prepared by the Search and Rescue Volunteer Association of Canada (<https://sarvac.ca/survival/>) prior to your reservation.
7. Life Jackets must be worn at all times on the water.
8. It is illegal to operate or permit others to operate a boat when under the influence of drugs or alcohol.
9. Musquodoboit Valley Outfitters reserves the right to cancel or alter any rentals due to weather (e.g., lightning, high winds), unsafe water levels (e.g., flooding), or other adverse conditions that may affect safety. We also reserve the right to deny service if we feel it is necessary for reasons of safety.

Payment and Cancellations

10. Payment is due following the confirmation of your reservation. Equipment will not be secured/guaranteed until payment is complete.
11. Cancellations must be made at least 24 hours prior to the start of your reservation to receive a full refund or credit if rescheduling. ‘No Shows’ and cancellations received within 24 hours of your reservation are not eligible for a refund.

Equipment and Reimbursement for Damages

12. The reservation holder agrees to accept the equipment in its present condition and accept full responsibility for the care of the equipment they are renting.
13. The reservation holder agrees to reimburse Musquodoboit Valley Outfitters for any damage to, or loss, or loss of use, of Musquodoboit Valley Outfitters property or equipment that may occur as a result of their, or any member of their party’s, actions during their rental at full retail cost. Loss of use shall be determined by revenue lost per hour, due to loss of equipment.
